Codes update with the new rates is now 78.38 hour instead of 76.00 hour

Process is the same for the file of complaints however there is a better condensed complaint form internally for the borough that the Borough Manager will use when filling out information for the COG

Bid packet information – Bid was open we received three bids Sikora Brothers Paving 677,760.00 Mid State Paving 479,310.00 Pine Mountain \$419,154.00

We will officially award this grant to the lowest bid which is Pine Mountain after the recommendation is given to us from our Engineer after all the legal documents have been received to them from Pine Mountain and they are all in order we will need to approve in the February meeting.

We will get an update of the approval of the ARPA funds from the County of 80,000 Borough Manager had meeting with County to request additional funds and they will confirm the additional amount.

South Side Recreation Authority – I did forward this information to our legal council and I will be working with the authority and South Williamsport and Armstrong Township to get more communication to council on what and how we can work together and take advantage of some shared grants for recreation.

No smoking in the park follow up on the signs we will be working on an ordinance for this.

Expenditures will be given in the February Meeting due to the date being January 2<sup>nd</sup>.
